In the following pages we have outlined some very important information which you may or may not be aware of, that affects us all, and helps to piece together the answers to "why did this disaster happen?" and, for those who lost their homes, "what can we do to protect our legal rights to stay on our land?"

In this time of immense change and destabilisation, our solutions should be ones that support our dignity, freedom and our sense of community...let's shift our pain into gain.

We the people must have an equal voice and awareness of the debates and solutions currently being put forward by our elected representatives, whose policies and agendas are historically based on profits, self-interest and political point-scoring. They are elected to serve the people, yet we repeatedly see financial gain dominate over the protection and prioritisation of our personal, communal, national and environmental wellbeing.

It is time to stand united and to stand up for our rights – or risk losing them as we know them. There is so much bias and agenda-driven cherry picking in our mainstream media, and presented by our politicians today. If you have followed the course of events and words spoken by these outlets and people over the past two years, you may have noticed a lack of consistency, clarity and logic has been prevalent – many things are contradictory, confusing and seemingly far from the most rational solution or course of action.

So, we invite you to digest this information, as tough as it may be. Start asking questions and getting informed, these events apply to each and every one of us. This information has been compiled by a number of people who have been heavily involved in studying and researching the geopolitical events of the last decade, with sincere concern for where we are, and where we are heading.

### **OUR COMMUNITY SAVED THE DAY**

Since the first day of the floods, our community rallied together, organising teams of people to get out to the most severely affected areas, saving lives and delivering essential resources. We've arranged food, accommodation, boat rescues, helicopter rescues, medications, clothing, water, machinery, hot meals, cleaning, rubbish removal, fundraising and the list goes on.



Still today, hundreds of people and volunteers are on the ground daily, managing all the moving parts of a community in recovery from a major crisis. Our community has raised millions of dollars to support the flood affected towns and regions, despite a breakdown of communications of telephone and internet for over a week. The resourcefulness and devotion displayed by the people of the Northern Rivers has been unparalleled and awe inspiring, to say the least.

"My son has not stopped, he was there as the boats were rescuing people, he has chopped down trees with dead cows caught in them, he has bought generators out of his own money to donate, and connected people with missing belongings. He is doing everything he can to help and support our people every day and keep up with the need, just like everyone else in our amazing community."

This is just one example of someone helping. There have been hundreds like him.

#### **OUR GOVERNMENT LET US DOWN**

It took government resources 6 days to show up, and even 4 weeks later, their efforts have been considerably minimal in relation to the scale of devastation — this first flood has been marked as the largest in 500 years.

What an equally inspiring and disillusioning testament. Inspiring for the sheer power of people, when united — disillusioning for the minimal urgency and concern from a government who claims to be here in service to us, for our health, safety and our quality of life. Our federal government has offered a mere \$3000 per flood affected person as compensation, yet has just sent \$70M to Ukraine and spent **\$2B** on a new submarine base. This is money spent with our tax paying dollars — yet in a time of disaster and displacement, our needs remain unmet and the government pours money into things that certainly do not serve the people, let alone the tens of thousands of people here in our community, now facing homelessness and poverty. If we are paying taxes, it is the responsibility of our elected government to utilise that money in a way that supports our safety, quality of life and freedom, is it not?

### WHY DID THIS WEATHER EVENT HAPPEN?

Over the past few decades, Australia and the rest of the world has implemented the use of geo-engineering and cloud seeding, a technique invented by Vincent J. Schaefer in 1946.

Cloud seeding involves using aircrafts or drones to add small particles of silver iodide to clouds. Water droplets cluster around the particles, modifying the structure of the clouds and increasing the chance of precipitation. This means rain can be manufactured.

Geo-engineering on the other hand, is the deliberate and large-scale intervention in the Earth's climate system, meaning all elements of our weather systems can be manipulated. Cloud seeding and weather manipulation were most popularly used by Australia and the US during the Vietnam War, as a fundamental part of their military strategy. A key question we pose here is that if this is possible, why was it not implemented to reduce such extreme rainfall? Or used to assist during the bushfires of 2019?

# **IS A LAND GRAB COMING?**

Many thousands of people in Lismore, Woodburn, Evans Head and surrounding flood damaged areas have been given notice that their homes are no longer inhabitable.

Approximately 200 First Nations residents of Cabbage Tree Island, just south of Ballina, have similarly had to desert their homes after being informed by SES assessors that they cannot come back for several years due to the unsafe living conditions. Lismore MP Janelle Saffin has flagged that, "buybacks, relocation and creating temporary villages to house people in pods" is on the agenda, and as of 15th March, Steph Cooke, Minister for Flood Recovery announced that to date, "the SES has assessed 2,774 buildings in the Lismore LGA and has deemed 2,016 of those buildings as no longer habitable."<sup>2</sup>

As this humanitarian disaster plays out, we urge everyone to pay close attention to the government campaigns and initiatives intended to "build back better", keeping in mind that "better" is a fundamentally subjective term. A key question to ask here is, who might it be "better" for? What the World Economic Forum would like us to live in. It is a summary of what the world economic members (including Australia) have in store for us. Check it out and decide if this is the world you want to live in? The WEF agenda is to make it so difficult for people to live on the land that the easiest solution will be to move to huge Smart Cities. and "you'll own nothing and be happy about it" – which is what members of the World Economic Forum keep telling us.

### HOW YOU CAN TAKE CONTROL OF YOUR FUTURE AND YOUR LAND

Here's an outline of how you can best approach any assessors or authorities intending to inspect your property.

#### If people come to offer to assess your home:

- 1. Don't make assumptions. Ask them exactly who they are and what they are here for.
- 2. Acknowledge them and thank them for their concern. Be polite and friendly. These people are just doing their job.

3. Inform them that you are perfectly capable of assessing your own living situation and that their services won't be needed.

4. Thank them for their time and send them on their way.

5. If necessary, and only if needed, inform them that they are trespassing and need to leave immediately.

**Bonus tip:** be the authority. Have in mind the intended outcome and you won't have anything to explain or defend. Remember this is an offer and they do not have the authority to push through your door without your consent. Only you decide whether or not they can come in.

# THE BIGGEST CONCERN FOR OUR LAND

An important fact to note, is that, if a piece of land is declared a 'disaster zone', it can be repossessed by the state under the guise of 'global climate change'.

A historical example of this is the 2009 and 2019 bushfires, "In the areas most at risk of bushfires, destroyed homes and infrastructure should arguably not be rebuilt at all. This has prompted calls for state governments to buy back land from people in areas most at risk, as happened after the 2009 Black Saturday fires."

In 2017, a Smart Train rail network plan was announced, to "Realise an industry vision for a world class rail industry, supporting a liveable and sustainable society, through next-generation digital and telecommunications technologies." The proposal outlines the route, which would link all the proposed Smart Cities to one another.



In 2019, Consolidated Land and Rail Australia Pty Ltd, formulated a \$200 billion proposal, "CLARA's mission is to build new liveable, sustainable and connected Smart Cities in Victoria and New South Wales and connect them by High Speed Rail."

If there are people living in these regions i.e. Northern Rivers region, then the proposed plan for developing the Smart Cities and the interconnecting rail won't be viable. On 15th March, Janelle Saffin announced, "this is early days, but we need to look at what is possible and how we can rebuild our communities smarter."

"The Smart Cities Plan provides a foundation for ongoing reform and cooperative action. It represents a new framework for cities policy at the Federal level—and it is a framework that will guide action across various portfolios, to deliver better outcomes for our cities, the people who live in them and all Australians."

# THE ULTIMATE GOAL IS AGENDA 21/30

The 2030 Agenda is a global framework of action for people, planet, prosperity, peace, and partnership. It is universal in nature, meaning that every country is committed to implementing the agenda.


This raises particular concern when looked at through the lens of democracy, privacy and the sovereignty of individuals, communities and nations.

#### **Considerations:**

- A Universal Base Income (UBI) establishes total government dependency, worldwide.
- Centralised digitisation of all systems and finances mass surveillance, tracking, data monitoring and control.
- Immense leverage for social compliance.
- Social credit system based on centralised digital ID.
- A small handful of people are responsible for all decisions and determining what is acceptable and what is not.
- Centralised food systems decrease access to organic and non-gmo produce.
- Oiminished diversity of available resources, lifestyles and choices.

# HOW IS AUSTRALIA A PART OF THIS BIGGER AGENDA?

As part of the United Nations Sustainable Development Goals (SDGs), the Australian Government signed onto the Paris Agreement in 2016 – a legally binding international treaty consisting of 196 nations, with the goal to limit global warming and reverse the effects of climate change.

Under the guise of combating climate change and meeting the targets of the Paris Agreement, many towns in Australia are already identified as ICLEI (Local Governments for Sustainability) cities, or 'Smart Cities'.

#### Here are the current ICLEI cities around Australia:

Blacktown, Byron Bay, Hobart, Adelaide, Adelaide Hills, Sydney, Yarra, East Gippsland, Liverpool, Mackay, Penrith, Perth, Port Phillip, Strathfield, Melbourne, Canberra, Ballarat, Brisbane, Joondalup, Mandurah, Melville, Vincent, Darebin, Georges River, Hunters Hill, Peppermint Grove, Unley, Mount Barker, Hobsons Bay, Mornington Peninsula, Snowy Monaro. ### THE GOOD NEWS! THESE ARE ACTIONS YOU CAN TAKE TO OWN YOUR FUTURE

- Support each other and cultivate strong communities.
- Start or join projects that benefit the communities sovereignty from corporations.
- Avoid supporting initiatives backed by council or government funding.
- Get in the habit of checking the financial backing of corporations, businesses, media outlets and initiatives.
- Support politicians who are consciously opposing Agenda 21 (avoid voting for Coalition, Labour or the Greens) a community council is currently being formed to hold council accountable.
- Have the courage to join local groups for connection, trade, support and barter meet ups.
- Ask more questions and talk to your neighbours.

- Use cash as often as possible.
- Prioritise buying local as often as possible + buy your produce from your local market.
- Keep some necessities on hand 3-12 weeks supply of food, cash, and fuel. Look at your home and land and see how you can disaster proof it.
- Buy assets that will hold value regardless of the dollar (e.g. precious metals).
- Look into local exchange trading systems LETS community monetary or exchange system.
- Spend some time setting up proper consultation processes within your community.
